1. COLLECTION AND USE OF YOUR PERSONAL INFORMATION

Basis Capital Markets UK Ltd. ("Basis" or "the Firm") respects the privacy rights of our clients. Our Privacy Policy will help you understand what personal data we collect, why we collect it, and what we do with it. Please take a moment to familiarise yourself with our privacy practices, and let us know if you have any questions by sending us an email or submitting a request through our website.

Basis collects personal information that you voluntarily provide on this Web site or offline in connection with your account application, including your name, address, email address, contact information, etc.

Do not provide information about others unless authorized to do so, and consent to have all information used, disclosed, and transferred under this Privacy Policy. By submitting the information about others, you represent and warrant that you are authorized to do so and that you have received authorization from the person about whom you are providing the information, and that person has consented to have all information used, disclosed, and transferred in accordance with this Privacy Policy.

We use this information for carefully considered business purposes, which include some or all of the following to:
